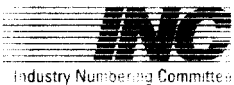
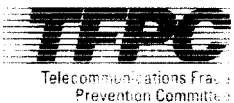
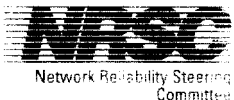

Dear Ms. Harmon:

The SMS/800 Number Administration Committee ("SNAC") would like to thank members of the Commission for meeting with Database Service Management, Inc. (DSMI), the SMS/800 Management Team (SMT), Telcordia Technologies, and other SNAC representatives on June 1, 2001. At this meeting, the SNAC expressed a need for additional time and further clarification regarding the FCC Disconnect and Suspend Order (DA-00-2754), and also discussed recommended suggestions as to how to implement this directive. The SNAC also discussed an implementation timeline, briefly outlined in the ATIS Ex Parte Presentation filed on June 8, 2001.

The Committee received valuable clarification at this meeting, which has enabled us to further define this requested timeline. The following is an outline of the SNAC's original recommended timeline, including additional information and steps that have been taken toward implementation:


June 20, 2001 – Telcordia Impact Analysis (Complete)
July 16-18, 2001 – SNAC Technical Subteam Design Review
July 25, 2001 – Full SNAC Design Approval
August 1, 2001 – SMS/800 Specifications Finalized
October 10, 2001 – Industry Testing Begins
December 8, 2001 – FCC Directive Implemented

This implementation schedule requires a four-month extension from the established implementation date of August 6, 2001. This proposed timeline would provide for a new implementation date of December 8, 2001.

The SNAC is requesting a response to this correspondence no later than July 9, 2001.
