Dear Ms. Shewman:

I am Thomas Goode, the General Counsel for the Alliance for Telecommunications Industry Solutions (ATIS). ATIS nominates Jackie Wohlgemuth, ATIS Director of Global Standards Development, to serve as ATIS' representative on the Federal Communications Commission's (FCC) North American Numbering Council (NANC) Call Authentication Trust Anchor (CATA) and Toll-Free: Future Utilization of Numbers (TFFUN) Working Groups. Ms. Wohlgemuth's resume is attached.

ATIS is a not-for-profit technical planning and standards development organization that develops and promotes technical and operational standards for communications and related information technologies worldwide. Experts from all segments of the information and communications technologies' (ICT) industry, including wireline, wireless, cable and equipment providers, as well as public safety agencies, actively participate in ATIS' open industry forums.

Ms. Wohlgemuth leads a number of key ATIS' committees/projects that are relevant to the CATA and TFFUN Working Groups, including the:

- ATIS Industry Number Committee (INC), which addresses and resolves issues associated with the planning, administration, allocation assignment, and use of numbering resources, and maintains twelve industry numbering guidelines, including the Thousands-Block & Central Office Code Assignment Guidelines (TBCOCAG);
- ATIS SMS/800 Number Administration Committee (SNAC), which identifies, develops, and resolves issues impacting toll-free products and services, and maintains the Industry Guidelines for Toll Free Number Administration;

- Joint ATIS and SIP Forum IP Network-to-Network (IP-NNI) Task Force, which develops and maintains the Signature-based Handling of Asserted information using toKENS (SHAKEN) series of standards for managing the deployment of Secure Telephone Identity (STI) technologies; and
- Non-IP Call Authentication (NIPCA) Task Force within ATIS' Packet Technologies and Systems Committee (PTSC), which focuses on call authentication for TDM-based Originating Service Providers (OSP) and Terminating Service Providers (TSP).

As ATIS' representative to these Working Groups, Ms. Wohlgemuth would be able to leverage ATIS' broad and diverse membership and the wide array of subject matter expertise available from ATIS members and staff to provide valuable input. Ms. Wohlgemuth has served as ATIS' representative to the NANC for over eight years and has served as the Chair of the NANC Call Authentication Trust Anchor Working Group since December 2017. Prior to joining ATIS in 2003, Ms. Wohlgemuth served as a Manager of Carrier Access Billing at Birch Telecom, where she was responsible for the implementation and ongoing billing of carrier access charges, as well as managing the billing operations team.

ATIS is committed to the success of the NANC and supports having Ms. Wohlgemuth serve on these NANC Working Groups for a two-year term or until the Working Group is disbanded.

Ms. Wohlgemuth is not a registered Federal lobbyist. Neither ATIS nor Ms. Wohlgemuth will receive reimbursement of travel expenses or honoraria from the NANC. Moreover, Ms. Wohlgemuth does not represent clients other than ATIS before the FCC or in matters that would come before the NANC or its Working Groups.

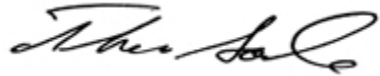
